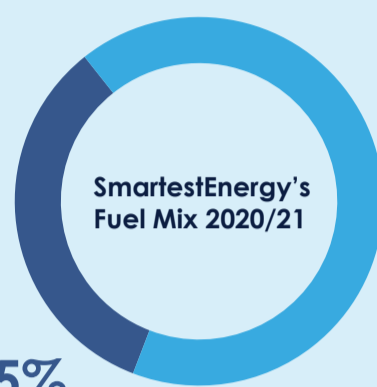

- > **October 2020:** MOU signed with CEP. Energy for next generation energy project managing a 400MW battery storage Virtual Power Plant (VPP).
- > **July 2021:** Completed a new deal with Providence Asset Group to deliver 500GWh of solar energy to the Australian National Electricity Market
